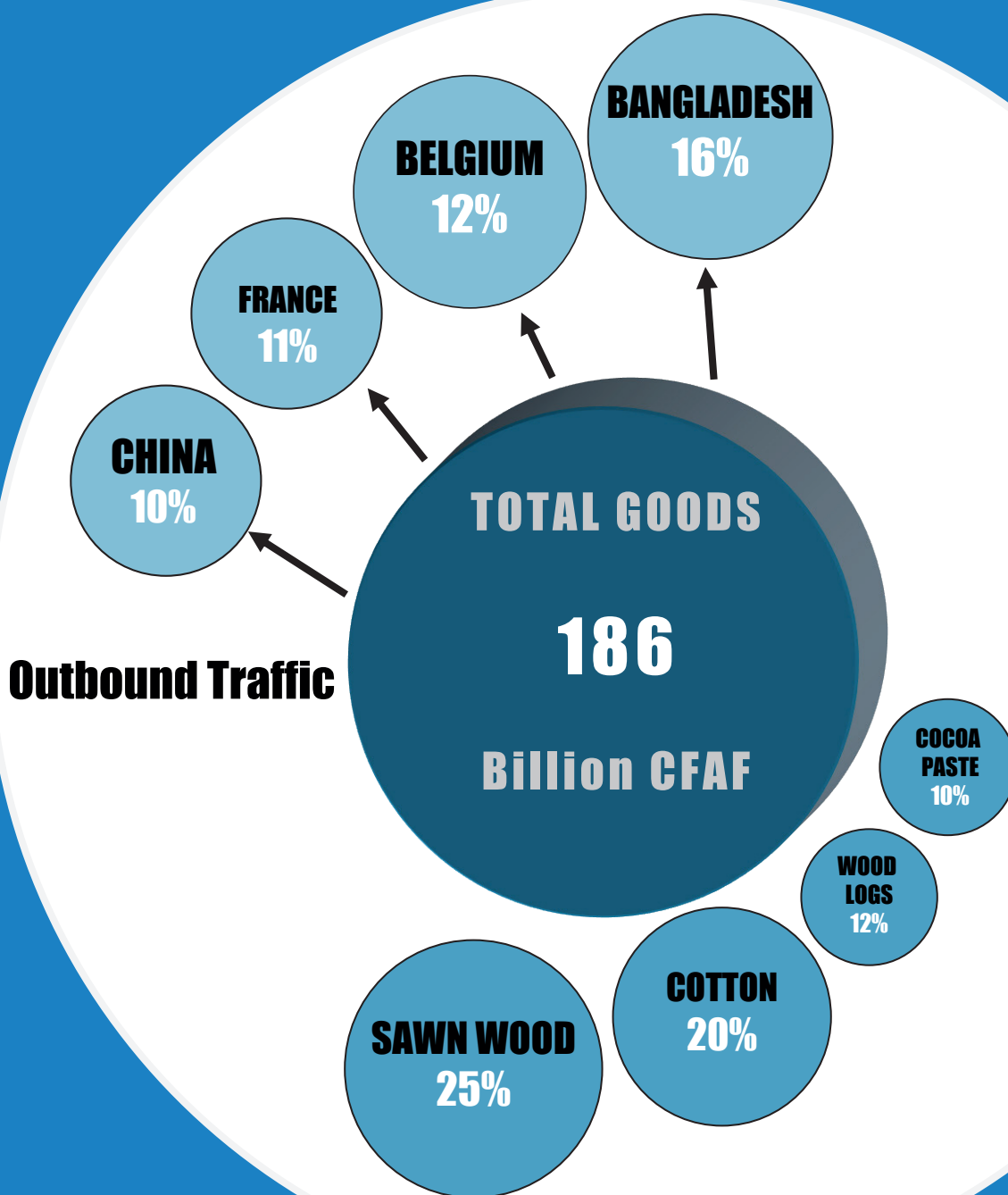

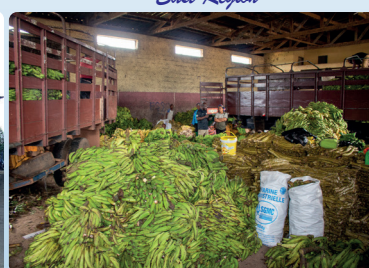

The Cameroon National Shippers' Council is pleased to put at your disposal the 62nd issue of the **"CNSC Book of Statistics"**.

This quarterly publication contains information sourced from the Electronic Cargo Tracking Note (ECTN) covering goods from or bound for Cameroon and passing through the ports of Douala and Kribi.

This issue of the CNSC Book of Statistics covering the second quarter of 2023 reveals that overall maritime traffic, except crude oil, registered a 5% year-on-year increase. With an FOB value of 1,237 billion CFAF, the volume of traffic stood at 3,025,059 tonnes against 2,689,381 tonnes with an FOB value of 1,179 billion FCFA in the second quarter of 2022.

Outbound traffic recorded a 37% year-on-year increase with a record 186 billion CFAF in the second quarter of 2023. In terms of volume, there was an increase from 497,010 tonnes recorded in the second quarter of 2022 to 462,378 tonnes in the second quarter of 2023.


Inbound traffic was up by 19% year-on-year. Statistics show that 2,562,381 tonnes of goods were offloaded in the second quarter of 2023 for a total of 1,051 billion CFAF, against 2,192,371 tonnes for a total of 882 billion CFAF in the second quarter of 2022.

The main ports that shipped goods to and received shipments from the Douala and Kribi ports in the second quarter of 2023 were Antwerp, Chittagong, Genoua, Hamburg, Jebel Ali, Le Havre, Lome, Nansha, Nhava Sheva, Ningbo, Qingdao, Rouen, Shanghai, Zhangjiagang, Valencia, Dakar, Mundra and Shekou.

This issue of the “*CNSC Book of Statistics*,” contains statistics of the **2nd quarter of 2023**. It is subdivided into two parts.

The first part (**Part A**) contains analysis of the evolution of traffic handled at the Douala and Kribi sea ports. This data is presented in terms of overall traffic, inbound traffic (**imports**) and outbound traffic (**exports**). It also relates to the evolution of trade with Cameroon’s main trading partners. This refers to the countries of loading and discharge of goods. To conclude, it equally focuses on the evolution of trade in main products.

In the second part (Part B), statistics on trade flows (**tonnage and FOB value**) by country, by port and by product are presented in detail. Data on the average freight rate for imported containers (**20-foot and 40-foot refrigerated or dry containers**) are presented at the end of this document.

The data used for the different analysis was sourced from the Electronic Cargo Tracking Note (ECTN).

The unit used is the **tonne** for weights and the **CFA Franc** for **FOB value** and **freight rates**.





DATA PRESENTATION

1. Evolution of trade at the Douala and Kribi Ports

1.1. Overall traffic

In Q2 2023, a total of 3 million tonnes of goods (excluding crude oil) loaded or discharged at the ports of Douala and Kribi were covered by an ECTN. This corresponds to a total value of 1,237 billion CFAF compared to 1,179 billion¹ CFAF in Q2 2022, representing a value increase of 5% year-on-year.

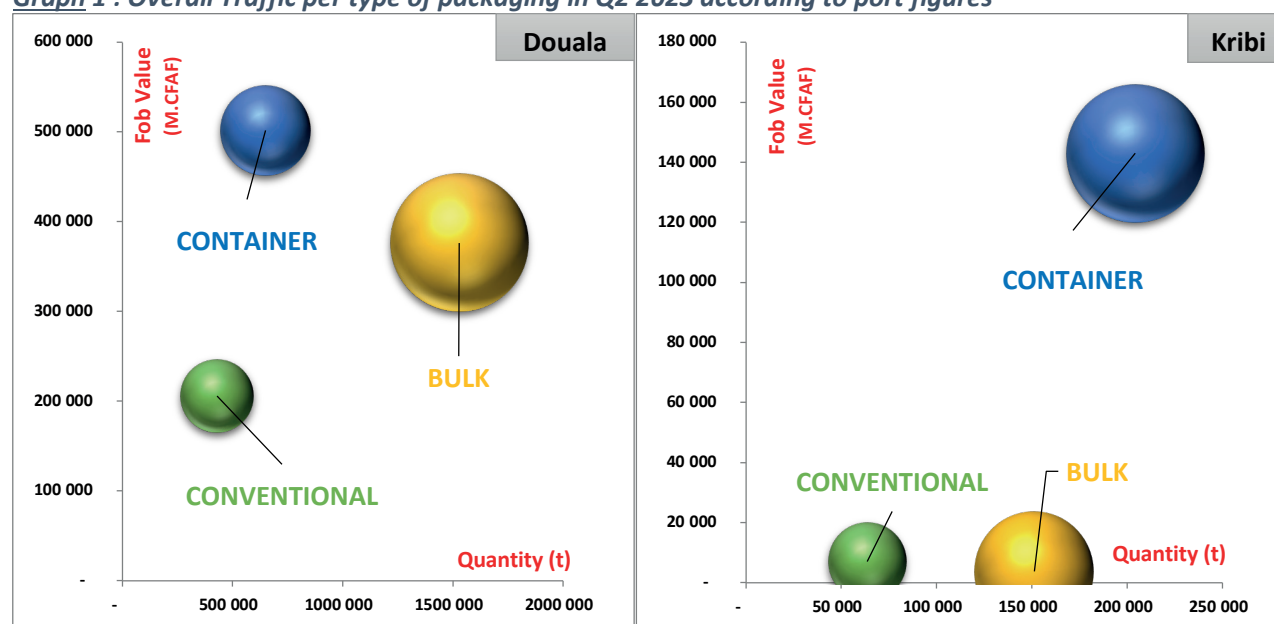

In the 2nd quarter of 2023, traffic at the Douala Port accounted for 88% of the overall traffic and was dominated by containerised goods, which accounted for 46% of the total traffic in this port all worth 501 billion CFAF for the 649 thousand tonnes of goods that passed through the port. Moreover, the port of Kribi witnessed a significant drop in the value of outgoing traffic for Q2 2023 resulting in a 6% year-on-year decrease.

1.2. Outbound traffic

Outbound traffic in the second quarter of 2023 stood at 462 thousand tonnes of goods for a value of 186 billion CFAF, reflecting a year-on-year value decrease of 37%. This decline stems from the 39% and 29% decline recorded in the ports of Douala and Kribi respectively.

1.3. Inbound traffic

During the period between April and June 2023, some 2.5 million tonnes of goods were offloaded at the ports of Douala and Kribi for an estimated value of 1,051 billion CFAF, compared with 882 billion CFAF for an estimated 2.2 million tonnes of goods in the second quarter of 2022. It should be noted that the value of conventional goods shipped through the port of Kribi increased more than 500-fold in the second quarter of 2023.

2. Main partners

2.1. Export partners

In the second quarter of 2023, 83% of the overall value of goods loaded at the ports of Douala and Kribi went mainly to ten countries, the top four being the **Bangladesh** (16%), **Belgium** (12%), **France** (11%) and **China** (10%).

Following a drop in the value of **Cotton** exports from 39 billion CFAF in the second quarter of 2022 to 28 billion CFAF in the second quarter of 2023, traffic to **Bangladesh** witnessed a 29% year-on-year decrease.

Exports to **Belgium** recorded a 27% year-on-year increase in the second quarter of 2023 and were dominated by the following products:

- ✓ **Sawn wood:** 12.6 billion CFAF in the second quarter of 2023 against 10.5 billion CFAF in the second quarter of 2022;
- ✓ **Banana:** 4 billion CFAF in the second quarter of 2023 against 3.5 billion CFAF in the second quarter of 2022;
- ✓ **Wood logs:** 2.4 billion CFAF in the second quarter of 2023 against 0.1

billion CFAF in the second quarter of 2022;

Value wise, exports to **France** recorded a 6% year-on-year increase in the second quarter of 2023 and the main products exported were:

- ✓ **Cocoa butter, fats and oil:** 8.7 billion CFAF in the second quarter of 2023 against 8.6 billion CFAF in the second quarter of 2022;
- ✓ **Unwrought aluminium:** 4.4 billion CFAF in the second quarter of 2023 against 3.4 billion CFAF in the second quarter of 2022;
- ✓ **Cocoa paste:** 2.9 billion CFAF in the second quarter of 2023 against 3.09 billion CFAF in the second quarter of 2022;
- ✓ **Sawn wood:** 2.4 billion CFAF in the second quarter of 2023 against 2.5 billion CFAF in the second quarter of 2022;

Exports to **China** recorded an 8% year-on-year increase in the second quarter of 2023 and were dominated by the following products:

- ✓ **Wood logs:** 11.4 billion CFAF in the second quarter of 2023 against 7.6 billion CFAF in the second quarter of 2022;
- ✓ **Sawn wood:** 4.2 billion CFAF in the second quarter of 2023 against 4.9 billion CFAF in the second quarter of 2022;
- ✓ **Natural rubber:** 1.6 billion CFAF in the second quarter of 2023 against 0.2 billion CFAF in the second quarter of 2022;

Exports to **Italy** recorded a 50% year-on-year decrease in the second quarter of 2023. The main products exported were:

- ✓ **Unwrought aluminium:** 5.6 billion CFAF in the second quarter of 2023 against 0.8 billion CFAF in the second quarter of 2022;
- ✓ **Sawn wood:** 3.2 billion CFAF in the second quarter of 2023 against 19.6 billion CFAF in the second quarter of 2022;
- ✓ **Plywood:** 2.8 billion CFAF in the second quarter of 2023 against 3.4 billion CFAF in the second quarter of 2022;

Exports to **Turkey** recorded an 81% year-on-year increase in the second quarter of 2023 and were dominated by the following products:

- ✓ **Cotton:** 4.9 billion CFAF in the second quarter of 2023 against 0.8 billion CFAF in the second quarter of 2022;
- ✓ **Sawn wood:** 1.8 billion CFAF in the second quarter of 2023 against 0.7 billion CFAF in the second quarter of 2022;

- ✓ **Unwrought aluminium:** 1.7 billion CFAF in the second quarter of 2023 against 0 CFAF in the second quarter of 2022.

Value wise, exports to **the Netherlands** recorded a 76% year-on-year drop in the second quarter of 2023. The main products exported were:

- ✓ **Cocoa paste:** 3.2 billion CFAF in the second quarter of 2023 against 2.3 billion CFAF in the second quarter of 2022;
- ✓ **Cocoa butter, fats and oil:** 1.8 billion CFAF in the second quarter of 2023 against 2.4 billion CFAF in the second quarter of 2022;
- ✓ **Unwrought aluminium:** 1.5 billion CFAF in the second quarter of 2023 against 0.9 billion CFAF in the second quarter of 2022;

Value wise, traffic to **Germany** increased by 39% year-on-year in the second quarter of 2023, following an increase in outflows of **Cocoa butter, fats and oil** (from 1.8 billion CFAF in Q2 2022 to 3.7 billion CFAF in Q2 2023) and **Cocoa paste** (from 1.8 billion CFAF in Q2 2022 to 2.8 billion CFAF in Q2 2023).

Following a decrease in the value of **Sawn wood** exports from 44.3 billion CFAF in the second quarter of 2022 to 2.9 billion CFAF in the second quarter of 2023, traffic to **Spain** dropped by 85%.

Exports to the **USA** recorded a 24% year-on-year decrease in the second quarter of 2023 and were dominated by the following products: **Cocoa paste** (4.9 billion CFAF in Q2 2023 compared with 5.8 billion CFAF in Q2 2022) and **Sawn wood** (1.8 billion CFAF in Q2 2023 compared with 1.8 billion CFAF in Q2 2022).

2.2. Import partners

In the second quarter of 2023, 73% of the overall value of goods that landed at the ports of Douala and Kribi came from eleven countries, with **Togo** topping the list thanks to its record **20%** share, followed by **China (17%)**, **Belgium (10%)** and **France (8%)**.

In the second quarter of 2023, imports from **Togo** increased by 52% year-on-year. The main products imported were:

- ✓ **Medium oils and preparations, of petroleum or bituminous minerals, not containing biodiesel:** 203.4 billion CFAF in the second quarter of 2023 against 139.9 billion CFAF in the second quarter of 2022;
- ✓ **Petroleum gases and other gaseous hydrocarbons:** 3.6 billion CFAF in the second quarter of 2023 against 0 CFAF in the second quarter of 2022.

Exports to **China** recorded a 46% year-on-year increase in the second quarter of 2023 and were dominated by the following products:

- ✓ **Insecticides/fungicides/herbicides:** 20.4 billion CFAF in the second quarter of 2023 against 8.8 billion CFAF in the second quarter of 2022;
- ✓ **Bulldozers, skew bulldozers, graders:** 8.4 billion CFAF in the second quarter of 2023 against 3.5 billion CFAF in the second quarter of 2022;

- ✓ **Cars and spare parts:** 12 billion CFAF in the second quarter of 2023 against 19.7 billion CFAF in the second quarter of 2022;
- ✓ **Cast iron, iron or steel:** 11.1 billion CFAF in the second quarter of 2023 against 8.7 billion CFAF in the second quarter of 2022;

The overall value of Imports from **Belgium** recorded a 13% year-on-year increase in the second quarter of 2023. The main products imported were:

- ✓ **Cars and spare parts:** 25.05 billion CFAF in the second quarter of 2023 against 27.05 billion CFAF in the second quarter of 2022;
- ✓ **Petroleum materials and equipment:** 11.3 billion CFAF in the second quarter of 2023 against 3.2 billion CFAF in the second quarter of 2022;
- ✓ **Mineral fuels, mineral oils and products of their distillation** 10.09 billion CFAF in the second quarter of 2023 against 1.2 billion CFAF in the second quarter of 2022;

Imports from **France** recorded a 17% year-on-year increase value wise in the second quarter of 2023. The main products imported were:

- ✓ **Pharmaceutical products:** 30.5 billion CFAF in the second quarter of 2023 against 22.7 billion CFAF in the second quarter of 2022;
- ✓ **Wheat:** 7.5 billion CFAF in the second quarter of 2023 against 4.7 billion CFAF in the second quarter of 2022;
- ✓ **Malt:** 4.6 billion CFAF in the second quarter of 2023 against 4.04 billion CFAF in the second quarter of 2022;
- ✓ **Beverages, spirits and vinegar:** 5.4 billion CFAF in the second quarter of 2023 against 3.7 billion CFAF in the second quarter of 2022;
- ✓ **Insecticides/fungicides/herbicides:** 3.8 billion CFAF in the second quarter of 2023 against 0.14 billion CFAF in the second quarter of 2022;

Imports from **India** recorded a 46% year-on-year increase in the second quarter of 2023 and mainly comprised of the following products:

- ✓ **Rice:** 35.9 billion CFAF in the second quarter of 2023 against 17.6 billion CFAF in the second quarter of 2022;
- ✓ **Pharmaceutical products:** 3.6 billion CFAF in the second quarter of 2023 against 5.6 billion CFAF in the second quarter of 2022;
- ✓ **Sugar:** 3.5 billion CFAF in the second quarter of 2023 against 3.2 billion CFAF in the second quarter of 2022;
- ✓ **Frozen fish:** 2.1 billion CFAF in the second quarter of 2023 against 0.9 billion CFAF in the second quarter of 2022;

Following an increase in the value of **Wheat** exports from 6.6 billion CFAF in the second quarter of 2022 to 11.5 billion CFAF in the

second quarter of 2023, traffic to **Germany** witnessed a 24% year-on-year increase.

In the second quarter of 2023, imports from **Spain** rose by 54% year-on-year. The main products imported were:

- ✓ **Clinker:** 3.1 billion CFAF in the second quarter of 2023 against 0.3 billion CFAF in the second quarter of 2022;
- ✓ **Groats, semolina and agglomerates in the form of pellets, cereals:** 1.6 billion CFAF in the second quarter of 2023 against 0.21 billion CFAF in the second quarter of 2022;
- ✓ **Insecticides/fungicides/herbicides:** 1.2 billion CFAF in the second quarter of 2023 against 0.007 billion CFAF in the second quarter of 2022;

Imports from **Nigeria** recorded a four-fold increase in the second quarter of 2023 and mainly comprised of the following products:

- ✓ **Cruise ships, excursion boats, ferry-boats, cargo ships, barges:** 3.6 billion CFAF in the second quarter of 2023 against 0 CFAF in the second quarter of 2022.
- ✓ **Cigars:** 2.2 billion CFAF in the second quarter of 2023 against 4.1 billion CFAF in the second quarter of 2022;
- ✓ **Clinker:** 1.9 billion CFAF in the second quarter of 2023 against 0 CFAF in the second quarter of 2022.

Following a drop in the value of **Rice** imports from 18 billion CFAF in the second quarter of 2022 to 15 billion CFAF in the second quarter of 2023, traffic from **Thailand** witnessed a 14% year-on-year decrease.

Following a drop in the value of **iron, cast iron and steel** imports from 11 billion CFAF in Q2 2022 to 0.6 billion CFAF in Q2 2023, traffic from **Turkey** fell by 44% year-on-year in Q2 2023.

3. Main products transported

3.1. Export products

Exports via the Ports of Douala and Kribi in the second quarter of 2023 were dominated by eleven key products accounting for 94% of the overall value of exports.

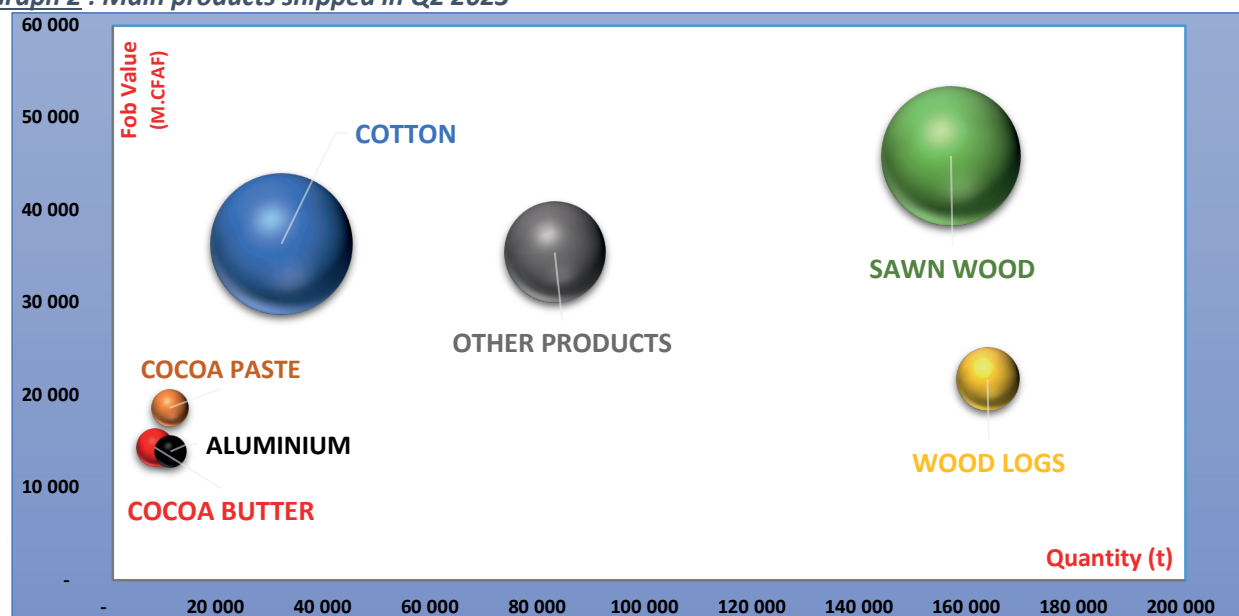

This traffic was dominated by **Sawn wood** representing 25% of the overall value of goods shipped, followed by **Cotton** (20%), **Wood logs** (12%) and **Cocoa paste** (10%). However, we note a sharp fall in the value of Sawn wood and Cotton exports, of around 54% and 35% year-on-year respectively.

3.2. Import products

Mineral fuels and mineral oils constituted the main products in the second quarter of the year 2023 with 416 thousand tonnes worth 234 billion CFAF and accounting for 22% of the total value of imports for the period under review. These were followed by **rice** (5%), **cars and spare parts thereof** (5%), **wheat** (4%), **pharmaceuticals** (4%), **cast iron and steel** (3%), **palm oil and its fractions** (3%), **frozen fish** (3%) and **insecticides/fungicides/herbicides** (3%).

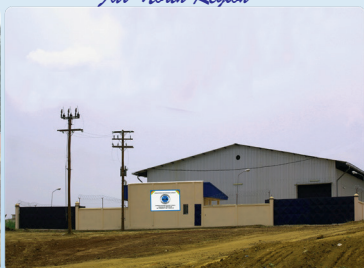

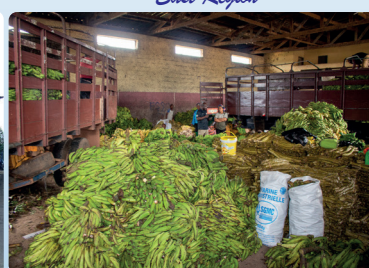

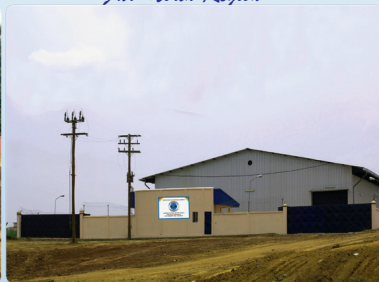
