

The Cameroon National Shippers' Council is pleased to put at your disposal the 58th issue of the "*CNSC Book of Statistics*".

This quarterly publication contains information sourced from the Electronic Cargo Tracking Note (ECTN) covering goods from or bound for the ports of Douala and Kribi.



This issue of the CNSC Book of Statistics which covers the second quarter of 2022 reveals that overall maritime traffic, except crude oil, registered a 31% year-on-year increase. With an FOB value of 1,192 billion CFAF, the volume of traffic stood at 2,800,693 tonnes against 2,964,034 tonnes with an FOB value of 913 billion CFAF in the second quarter of 2021.

Outbound traffic recorded a 48% year-on-year increase with 297 billion CFAF in the second quarter of 2022. In terms of Volume, there was an increase from 483,436 tonnes in the second quarter of 2021 to 497,010 tonnes in the second quarter of 2022.

Inbound traffic was up by 24% year-on-year. Statistics show that 2,192,371 tonnes of goods were offloaded in the second quarter of 2022 for a total of 883 billion CFAF, against 2,480,597 tonnes for a total of 713 billion CFAF in the second quarter of 2021.

The main ports that shipped goods to and received shipments from the Douala and Kribi Ports in the second quarter of 2022 were **Lome, Zhangjiagang, Aliaga, Antwerp, Port-Saïd, El-Dekheila, Oran, Kakinada, Djen Den, Haiphong, Koh Sichang, Agadir, Ningbo, Hamburg, Le Havre and Nansha.**

This issue of the “**CNSC Book of Statistics**,” contains statistics of the Second quarter of 2022. It is subdivided into two parts.

The first part (Part A) contains analysis of the evolution of traffic handled at the Douala and Kribi sea ports. This data is presented in terms of overall traffic, inbound traffic (**imports**) and outbound traffic (**exports**). It also relates to the evolution of trade with Cameroon’s main trading partners. This refers to the countries of loading and discharge of goods. To conclude, it equally focuses on the evolution of trade in main products.

In the second part (**Part B**), statistics on trade flows (**tonnage and FOB value**) by country, by port and by product are presented in detail. Data on the average freight rate for imported TEU (**refrigerated or dry**) are presented at the end of this document.

The data used for the different analyses was sourced from the Electronic Cargo Tracking Note (**ECTN**).

The unit used is the tonne for weights and the **CFA Franc for FOB value and freight rates**.



DATA PRESENTATION

1. Evolution of trade at the Douala and Kribi Ports

1.1. Overall traffic

In Q2 2022, a total of 2.8 million tonnes of goods (excluding crude oil) loaded or discharged at the ports of Douala and Kribi were covered by an ECTN. This corresponds to a total value of 1,192 billion CFAF compared to 913 billion¹ CFAF in Q2 2021, representing a value increase of 31% year-on-year.



In the 2nd quarter of 2022, traffic at the Douala Port accounted for 86% of the overall traffic and was dominated by containerised goods, which accounted for 55% of the total traffic in this port all worth 563 billion CFAF for 631 tonnes of goods that passed through the port. A remarkable increase in traffic is also observed at the Port of Kribi spurred by a widespread use of bulk packaging modes in the course of the second quarter of 2022. Traffic at the Kribi port was worth 12 billion for a total of 111 thousand tons of goods.

1.2. Outbound traffic

Outbound traffic in the second quarter of 2022 stood at 497 tonnes of goods for a value of 297 billion CFAF, reflecting a year-on-year value increase of 48%. This increase in outbound traffic was observed in both ports.

1.3. Inbound traffic

For the period between April and June 2022, some 2.2 tonnes of goods were offloaded at the ports of Douala and Kribi for an estimated value of 883 billion CFAF, compared with 713 billion CFAF for an estimated 2.5 million tons of goods in the second quarter of 2021.

2. Main partners

2.1. Export partners

About 81% of the overall value of goods loaded at the ports of Douala and Kribi in the second quarter of 2022 went mainly to ten countries, the top four being Spain (17%), Bangladesh (14%), the Netherlands (13%) and Italy (9%).

Following the drop in the value of Cocoa beans exports from 2 billion CFAF in the second quarter of 2021 to 44 billion CFAF in the second quarter of 2022, traffic to **Spain** increased by 633%.

With an increase in the value of cotton exports from 26 billion CFAF in the second quarter of 2021 to 40 billion CFAF in the second quarter of 2022, traffic to **Bangladesh** recorded a 49% growth rate.

Owing to a drop in the value of Cocoa beans exports from 37 billion CFAF in Q2 2021 to 31 billion CFAF in Q2 2022, traffic to the **Netherlands** was down by 3%.

Exports to **Italy** recorded a 134% year-on-year increase in the second quarter of 2022. The main products imported were:

- ✓ **Sawn wood:** 20 billion CFAF in the second quarter of 2022 against 4 billion CFAF in the second quarter of 2021;
- ✓ **Plywood:** 3.4 billion CFAF in the second quarter of 2022 against 2.9 billion CFAF in the second quarter of 2021;
- ✓ **Unwrought aluminium:** 0.9 billion CFAF in the second quarter of 2022 against 2.5 billion CFAF in the second quarter of 2021;

Value-wise, exports to **France** recorded a 20% year-on-year increase in the second quarter of 2022 and were dominated by the following products:

- ✓ **Cocoa butter, fats and oil:** 9 billion CFAF in the second quarter of 2022

against 8 billion CFAF in the second quarter of 2021;

- ✓ **Unwrought aluminium:** 3.4 billion CFAF in the second quarter of 2022 against 1.8 billion CFAF in the second quarter of 2021;
- ✓ **Cocoa paste:** 3.09 billion CFAF in the second quarter of 2022 against 3.02 billion CFAF in the second quarter of 2021;
- ✓ **Sawn wood:** 2.6 billion CFAF in the second quarter of 2022 against 2.2 billion CFAF in the second quarter of 2021;

Exports to **China** recorded a 2% year-on-year increase in the second quarter of 2022. The main products imported were:

- ✓ **Wood logs:** 8 billion CFAF in the second quarter of 2022 against 11 billion CFAF in the second quarter of 2021;
- ✓ **Sawn wood:** 5 billion CFAF in the second quarter of 2022 against 4 billion CFAF in the second quarter of 2021;
- ✓ **Cotton:** 2.8 billion CFAF in the second quarter of 2022 against 0.4 billion CFAF in the second quarter of 2021;

Exports to **Belgium** recorded a 24% year-on-year increase in the second quarter of 2022. and were dominated by the following products:

- ✓ **Sawn wood:** 11 billion CFAF in the second quarter of 2022 against 7

billion CFAF in the second quarter of 2021;

- ✓ **Banana:** 3.6 billion CFAF in the second quarter of 2022 against 3.4 billion CFAF in the second quarter of 2021;
- ✓ **Cocoa beans:** 1.2 billion CFAF in the second quarter of 2022 against 1.9 billion CFAF in the second quarter of 2021;

Exports to the **USA** rose by 46% year-on-year in the second quarter of 2022, following a 72% increase in the value of Cocoa paste exports to that country, which went from 3.4 billion CFA francs in the second quarter of 2021 to 5.9 billion CFA francs in the second quarter of 2022.

The increase in the value of sawn timber exports from 0.4 billion CFAF in Q2 2021 to 9.5 billion CFAF in Q2 2022 largely contributed to the increase in traffic to **India** which had a growth rate of 819%.

Following an increase in the value of Cocoa beans exports from 5 billion CFAF in the second quarter of 2021 to 9 billion CFAF in the second quarter of 2022, traffic to **Indonesia** increased by 79%.

2.2. Import partners

In the second quarter of 2022, 72% of the overall value of goods that landed at the ports of Douala and Kribi came from twelve countries, with Togo topping the list with a record 16% share, followed by China (14%), Belgium (11%) and France (8%).

In the second quarter of 2022, imports from **Togo** increased by 16% year-on-year. The main products imported were:

- ✓ **Medium oils and preparations, of petroleum or bituminous minerals, not containing biodiesel:** 82 billion CFAF in the second quarter of 2022 against 68 billion CFAF in the second quarter of 2021;
- ✓ **Crude petroleum oils or oils obtained from bituminous minerals:** 51 billion CFAF in the second quarter of 2022 against 0 CFAF in the second quarter of 2021.

Exports to **China** recorded a 15% year-on-year increase in the second quarter of 2022 and were dominated by the following products:

- ✓ **Cars and spare parts:** 20 billion CFAF in the second quarter of 2022 against 6 billion CFAF in the second quarter of 2021;

- ✓ **Cast iron, iron or steel:** 9 billion CFAF in the second quarter of 2022 against 17 billion CFAF in the second quarter of 2021;
- ✓ **Ceramic products:** 4 billion CFAF in the second quarter of 2022 against 3 billion CFAF in the second quarter of 2021;
- ✓ **Insecticides/fungicides/herbicides:** 8.7 billion CFAF in the second quarter of 2022 against 8.7 billion CFAF in the second quarter of 2021;
- ✓ **Rubber and articles thereof:** 6 billion CFAF in the second quarter of 2022 against 5 billion CFAF in the second quarter of 2021;
- ✓ **Plastics and articles thereof** 8 billion CFAF in the second quarter of 2022 against 7 billion CFAF in the second quarter of 2021;

Imports from **Belgium** recorded a year-on-year increase of 21% in the second quarter of 2022 for a value of 98 billion CFAF and mainly comprised of the following products:

- ✓ **Cars and spare parts:** 27.05 billion CFAF in the second quarter of 2022 against 27.12 billion CFAF in the second quarter of 2021;
- ✓ **Petroleum materials and equipment:** 3.2 billion CFAF in the second quarter of 2022 against 0.4 billion CFAF in the second quarter of 2021;
- ✓ **Worn clothing:** 1.8 billion CFAF in the second quarter of 2022 against 1.9 billion CFAF in the second quarter of 2021;

Exports to **France** recorded a 3% year-on-year increase in the second quarter of 2022 and the main products imported were:

- ✓ **Pharmaceutical products:** 23 billion CFAF in the second quarter of 2022 against 13 billion CFAF in the second quarter of 2021;
- ✓ **Wheat:** 5 billion CFAF in the second quarter of 2022 against 7 billion CFAF in the second quarter of 2021;
- ✓ **Malt:** 4.04 billion CFAF in the second quarter of 2022 against 3.72 billion CFAF in the second quarter of 2021;
- ✓ **Beverages, spirits and vinegar:** 3.8 billion CFAF in the second quarter of 2022 against 2.8 billion CFAF in the second quarter of 2021;

Imports from **India** recorded a year-on-year increase of 14% in the second quarter of 2022 and mainly comprised of the following products:

- ✓ **Rice:** 18 billion CFAF in the second quarter of 2022 against 20 billion CFAF in the second quarter of 2021;
- ✓ **Pharmaceutical products:** 6 billion CFAF in the second quarter of 2022 against 4 billion CFAF in the second quarter of 2021;
- ✓ **Sugar:** 3 billion CFAF in the second quarter of 2022 against 0 CFAF in the second quarter of 2021.

3. Main products transported

3.1. Export products

Exports via the Ports of Douala and Kribi in the second quarter of 2022 were dominated by ten key products accounting for 95% of the overall value of exports.

In the second quarter of 2022, imports from **Turkey** rose by 68% year-on-year and mainly comprised of the following products:

- ✓ **Cast iron, iron or steel:** 11 billion CFAF in the second quarter of 2022 against 2 billion CFAF in the second quarter of 2021;
- ✓ **Clinker:** 4.2 billion CFAF in the second quarter of 2022 against 4.7 billion CFAF in the second quarter of 2021;
- ✓ **Sugars and sugar confectionery:** 1.5 billion CFAF in the second quarter of 2022 against 0.8 billion CFAF in the second quarter of 2021;

In terms of value, imports from **Argentina** were up by 388% in Q2 2022 year-on-year. This is due to the high rate of Wheat imports (from 0 CFAF in Q2 2021 to 20 bn CFAF in Q2 2022), and increased inflows of Soybean meal (from 5 bn CFAF in Q2 2021 to 6 bn CFAF in Q2 2022) and Maize (from 0.4 bn CFAF in Q2 2021 to 1.7 bn CFAF in Q2 2022)

Flows from **Italy** increased by 5% in Q2 2022 year-on-year. This increase is due to the rise in inflows of cast iron, iron and steel structures (from 2.6 bn CFAF in Q2 2021 to 6.6 bn CFAF in Q2 2022) and constructions and parts of constructions (from 2.5 bn CFAF in Q2 2021 to 6.5 bn CFAF in Q2 2022).

With an increase in rice imports from 10 billion CFAF in Q2 2021 to 18 billion CFAF in Q2 2022, making up 98% of overall imports from **Thailand**, imports from that country went up by 78%.



Traffic in this direction mainly comprised of Sawn wood which accounted for 34% of the total value of goods shipped, followed by cotton (19%), and Cocoa beans (18%). Moreover, these first three products which account for 71% of the overall value, show positive year-on-year growth rates, which had an impact on the overall value of trade (48%).

3.2. Import products

Mineral fuels and mineral oils constituted the main products in the second quarter of the year 2022 with 299 thousand tonnes worth 159 billion CFAF and accounting for 18% of the total value of imports for the period. Next in line were vehicles and their parts (6%), Wheat (6%), Rice (5%), cast iron, iron and steel (4%), pharmaceutical products (4%) and frozen fish (4%).






