#### Dear shippers,

he Cameroon National Shippers' Council (CNSC) organised a number of activities in the month of June 2024 to the benefit of business persons and small and medium-sized enterprises, notably those of the Ad-Hoc Sub-Committee charged with facilitating the implementation of the AfCFTA (African Continental Free Trade Area) Guided Trade Initiative, chaired by the CNSC. The Ad-Hoc Sub-Committee convened a meeting of its members to review its activities, progress and challenges since the start of the year 2024.

As far as progress is concerned, the Sub-Committee is preparing for Cameroon's first containerised export under AfCFTA to Algeria consisting of four 20-foot containers of aluminium produced by ALUCAM.

On the cooperation front, the CNSC welcomed a delegation from the Chadian Shippers' Council which came to learn from CNSC's experience in providing assistance to shippers and facilitating foreign trade operations.

Lastly, this month's publication reports on the CNSC's celebration of the Feast of Tabaski, organised at the Dibamba Trucker Accommodation Centre with road transport stakeholders and in accordance with the precepts of the muslim faith.

#### Sea freight in Africa

UASC and African Shippers' Councils discuss recurrent price hikes.

The Governor of the Littoral Region, Mr. Samuel Ivaha Diboua, presided over the opening ceremony of the seminar organised by the Union of African Shippers' Councils (UASC) from 4 to 6 June 2024 at the Douala Maritime Museum. Discussions at the seminar focused on issues relating to maritime freight rates as evoked by the seminar's central theme, "The challenges of international maritime freight for African shippers". In addition to the speech by the Governor of the Littoral Region, participants also listened to other speeches by UASC's Secretary General, Mr. Abba Kafougou, and Mr. Auguste Mbappe Penda, General Manager of

the CNSC and UASC Statutory Treasurer. These two speakers called for a reduction in freight rates to enable Africa to effectively participate in global trade. This was identified by CNSC's General Manager as an important step in the fight against rising living costs in African countries. Fourteen (14) UASC member states from West and Central Africa took part in the seminar. Over three days, participants examined the factors behind the steady increase in the cost of transporting goods by sea in Africa. Together, they defined strategies for negotiating sea freight. Other solutions proposed by participants included the professionalisation of sector players and the strengthening of the competitiveness of Africa's ports. Participants left the seminar well informed about developments in international regulations governing the carriage of goods by sea, as well as the issues at stake and the persistent tussle between shipowners and shippers.

#### Delivering concrete results

First containerised export underway.



Working session

he General Manager of the Cameroon National Shippers' Council, who doubles as Chairman of the Ad-Hoc Sub-Committee charged with monitoring and implementing the AfCFTA Guided Trade Initiative in Cameroon, Mr. Auguste Mbappe Penda, presided over a working session that mainly focused on Cameroon's first containerised export under the AfCFTA preferential regime. This working session was an opportunity for the subcommittee to carry out a mid-year assessment of its activities since the start of the year 2024. It emerged that some companies which took part in the Intra-African Trade Fair (IATF) in November 2023 are envisaging exports to different countries on the African continent. One of them is ALUCAM, which has received a letter of credit for 4 containers of aluminium destined for Algeria. Another example is Laboratoires Roger Ducos, whose products will soon be received in Gabon and Mali. Note that the Sub-Committee's mission is to help Cameroonian shippers take full advantage of this preferential regime to trade across the continent, with a 90% reduction in tariff lines. The very first symbolic exports of dried tea and safflower were made through the Douala International Airport to Accra-Ghana in October 2022.

### Intra-African trade

n 21 June 2024, the General Manager of the Cameroon National Shippers' Council (CNSC), Mr. Auguste Mbappe Penda, welcomed a powerful delegation of 23 experts from Regional Economic Commissions (RECs), the African Development Bank (AfDB), the United Nations Conference on Trade and Development (UNCTAD), academia, civil society and the private sector on a working visit in Cameroon. Discussions essentially revolved around Cameroon's potential to benefit from regional value chains in the pharmaceutical, textile and automotive industries. This initiative was prompted by the due consideration of Cameroon's rich soil and the value of these products on the international market. The goal is to improve intra-African trade by eliminating any obstacles to a smooth integration process. Hosting the delegation from ECA, Mr. Auguste Mbappe Penda, who doubles as Chairman of the Ad Hoc Sub-Committee charged with the monitoring and implementation of the AfCFTA Guided Trade Initiative, underscored Cameroon's leading role in promoting the implementation of the AfCFTA through sub-regional integration and intra-African trade in Central Africa. «Cameroon was one of the first eight countries to ratify the AfCFTA Agreement and has already carried out its first imports and exports. Our ultimate goal is to improve intra-African trade», he pointed out to his audience. In response, the delegation of international experts encouraged the CNSC to continue the training workshops regularly organised for shippers, and above all to encourage businesses of the private sector to consider investing in wood and cotton processing. These products have a consumer market of one billion three hundred million people on the African continent.
