UASC holds strategic meeting in Douala

Prom 8 to 9 June 2023, the Cameroon National Shippers' Council **(CNSC)** hosted the 3rd session of the Union of African Shippers' Councils **(UASC)** Expert Committee on transport costs at its head office in Douala. The opening ceremony was presided over

by CNSC's General Manager, Mr Auguste Mbappe Penda, who also happens to be UASC's Statutory Treasurer, and was attended by UASC's Secretary General, Mr Giscard Lilian Ogoula.

The Experts' committee set up by Standing Committee No. 1 is

tasked with carrying out in- *GM CNSC open* depth studies on the impact of high maritime transport costs and other additional costs on the passage of goods through ports in West and Central Africa. The ultimate goal is to propose effective measures to reduce these costs.

Mr. Agu Cajetan, representing the Chairperson of Standing Committee No. 1, held by a Nigerian,

outlined the objectives of the meeting which are to determine the components of transport costs and other logistics costs in the supply chain in West and Central Africa, and to identify all surcharges and tariff headings applicable in West and Central Africa. In addition, the

Expert Committee needs find justifications. to or otherwise. for all surcharges and tariff headings identified in the sub-region, and to pinpoint the factors responsible for delays and high costs in customs cargo clearance West and Central in Africa. Lastly, the experts

Working session were expected to examine the factors responsible for high transport costs in West and Central Africa, and recommend appropriate measures to remedy the incidence of high transport costs. This session was a follow-up to the first two meetings held in Lagos, Nigeria, on 27 and 28 June 2022, and in Accra, Ghana, on 25 and 26 April 2023.

n 21 June 2023, the Minister of Transport, Mr. Jean Ernest Massena Ngalle Bibehe, presided over the opening ceremony of the International Symposium organised by the Cameroon National Shippers' Council (CNSC) under the coordination of its General Manager, Mr. Auguste Mbappe Penda. For 3 days, from 21 to 23 June, professionals of the maritime transport sector converged in Kribi to discuss on «The challenges of maritime insurance in African countries». Through this symposium, the CNSC seeks to equip Africa's business persons and other stakeholders with cutting-edge tips and skills, so that they can take full advantage of the benefits of maritime insurance, guaranteeing fair compensation in the event of an incident. Invited panellists discussed topics such as the general framework of maritime insurance in Africa, the outline of limited liability in marine insurance, the diversity of maritime insurance, the technical aspects of maritime insurance, additional compensation schemes derived from IMO conventions, and on aspects relating to maritime insurance litigations. A total of 13

maritime law experts attended both in person and via zoom, including Professors Philippe Delebecque (President of the Association Française du Droit Maritime and Chairman of the Maritime Arbitration Chamber of Paris) and Martin Ndende (Professor of Private Law and Criminal Sciences in French universities specialising in Law of the Sea and maritime activities), and Director of the Maritime and Oceanic Law Centre (CDMO) at the University of Nantes). Shippers, import/export managers, customs declarants. brokers. customs loaistics managers, transit agents, purchase managers, business persons involved in international trade, professionals and academia with particular interest in maritime insurance in West and Central African countries were fully satisfied with both the discussions and lessons drawn from this symposium, as well as the warm welcome that was accorded them. «The CNSC has taken away the veil, and now we understand better», a number of participants remarked visibly satisfied.

The first thing we should take home from this symposium is that we lose a lot of money on the international market because our goods are insured by foreign insurance companies. However, in 1975, a law was enacted in Cameroon making local insurance compulsory, and similar laws have been passed in other African countries. We must now aim for the effective implementation of this law which will enable us to grow our local insurance market. That is why we should sell CIF and buy FOB so as to better master our foreign trade, protect it and strengthen our local

market. The second lesson resides in our overview of the different types of insurance.

> of the presentation was to provide participants with information on the various procedures of international maritime transport for imported goods, and to highlight the CNSC's contribution in facilitating these procedures in Cameroon.

It is noteworthy that the Livestock Development

Project (PRODEL) seeks to improve the productivity of selected production systems, market their products to targeted beneficiaries and provide a rapid and effective response in the event of a crisis or emergency in the livestock sector. In recent times, a series of factors such as poor training, health issues, poor counselling services, limited access to credit or financing, and limited access to processing and marketing infrastructure, have led to low productivity and production among livestock farmers.
