GM CNSC presents new ECTN application "BESC 3.0

he General Manager of the Cameroon National Shippers' Council (CNSC), Mr. Auguste Mbappe Penda, chaired an awareness-raising session on the new version of CNSC's ECTN issuance application dubbed BESC 3.0, on Monday 27 January 2025 in Paris, France, flanked by his closest collaborators Mr. Mvondo Ekanga Tobie and Mr. Koum Claude Cyriac, respectively Head of the CNSC Paris Office and Information Systems Division. The meeting was attended by importers and exporters of goods bound for and leaving Cameroon and was an opportunity for the CNSC to present the new procedure for ECTN issuance via the "BESC 3.0" application, in force since the 1st of January 2025. This new and dynamic digital platform offers several new features. From a functional point of view, the new application offers simpler procedures for collecting and processing data and different electronic payment options. It is also expected to make it easier for users to initiate ECTN requests regardless of their geographical location. The same awareness-raising session was held in Cameroon, at the CNSC South Regional Office on 20 and 21 February 2025. This was at the request of shippers using the port of Kribi for their operations. Many of them, along with forwarding agents, customs brokers, and other foreign trade professionals who took part in the training session had been experiencing enormous difficulties since the launch of the new application. Mr. Elvis Tsaguim and Mr. Claude Koum, respectively CNSC Director for Operations and Head of the Information Systems Division, explained the functioning, innovations and advantages of BESC 3.0 to the participants.


International Customs Day

As a reminder, in August 2022, the CNSC and the Cameroon Customs Department signed a Memorandum of Understanding for the sharing of information and statistical data on Cameroon's foreign trade activities.

For the CNSC, the Service Head for Development, **Mr. Thierry Ekembe**, presented its new ECTN issuance application "BESC 3.0". This training seminar was well attended by the business community, with a total of about 150 foreign trade actors in attendance.

Cameroon's delegation to the 4th International Conference on the Blue Economy held from 19 to 21 February 2025 in Banjul, Republic of the Gambia, was led by Transport Minister Jean Ernest Massena Ngalle Bibehe. The event which had as its central theme *"Harnessing the Blue Economy: Leveraging Innovative and Sustainable Development"*, was organised by the Regional Maritime University in collaboration with the Maritime Institute of Dar es Salaam, under the auspices of the Gambian Ministry of Transport, Works and Infrastructure. Alongside the Port Authority of Douala, the Port Authority of Kribi, and the National Ports Authority, the Cameroon National Shippers' Council was represented by Mrs. Armelle Makasso and Mr. Thierry Mebara, respectively Sub-Director for Shippers' Assistance and Service Head for International Cooperation. The event brought together over 600 participants, including policy-makers, experts and business owners. Discussion at the 3-day conference focused on intriguing issues relating to the governance of oceans and coastal waters, maritime transport and safety, blue technology, and innovation. They discussed strategies for maximizing the benefits of the blue economy while ensuring environmental sustainability.
