### Dear shippers,

n keeping with its mission to support and assist shippers, the Cameroon National Shippers' Council (CNSC), Your *Partner*, organised a series of events for Cameroon's foreign trade players. These included a capacity-building workshop on airfreight procedures, which was attended by several sector players whose goods pass through Cameroon's airports.

The Syndicat National des Sociétés de Traitement, d'Hygiène, d'Assainissement et des Revendeurs du Matériel Phytosanitaire (SYNTHAR-PHYTO) called off its strike thanks to CNSC's mediation. Through a meeting which brought together professionals of the phytosanitary treatment sector at the Port of Douala, the CNSC succeeded to find common ground between the parties and thus defused the crisis triggered by the introduction of a fee of 700 F CFA/ tonne or m<sup>3</sup> of merchandise by the Port Authority of Douala.

This edition of the Shippers' Newsletter also reports on the CNSC's participation in the 10<sup>th</sup> session of the International Maritime Organisation's (IMO) Sub-Committee on the Carriage of Cargoes and Containers (CCC). Since mid-November 2024, the Douala Maritime Museum, which recently took part in the International Tourism and Travel Show in France, has been hosting a photography exhibition on the life of internationally acclaimed Cameroonian saxophonist Manu Dibango.

#### CNSC calms the storm

Phytosanitary treatment companies call off strike action.

he General Manager of the Cameroon National Shippers' Council (CNSC), Mr. Auguste Mbappe Penda, presided over a consultation meeting on 12 October 2024 at the CNSC head office building with the Syndicat National des Sociétés de Traitement, d'Hygiène, d'Assainissement et des Revendeurs du Matériel Phytosanitaire (SYNTHAR-PHYTO). This trade union had called a strike in protest to the 700 F CFA/tonne or m³ fees recently introduced by the Port Authority of Douala. The meeting was an opportunity for all sector stakeholders, including the Ministry of Agriculture and Rural Development, the National Ports Authority (NPA), the Port Authority of Douala (PAD), exporters and trade unionists, to examine the issue that had for several days paralysed exports via the Port of Douala. Three key recommendations emerged from the discussions, including the calling off of the strike, the suspension of the new measure through an official correspondence from PAD to MINADER, and the scheduling of a consultation meeting between PAD and the different trade unions involved in the phytosanitary treatment of goods. The purpose of such a meeting will be to agree on an applicable fee before the end of the year 2024. At the end of the meeting, the Secretary General of SYNSTHAR-PHYTO, Mr. Didier Balequel, reassured participants that steps would be taken as of 12 November 2024 to call off the strike. The CNSC's mediation in resolving the crisis was warmly commended by all parties involved.

#### Better safety for containers and cargoes

CNSC attends session in London.

he Cameroon National Shippers' Council (CNSC) was present at the 10th session of the Sub-Committee on Carriage of Cargoes and Containers (CCC) of the International Maritime Organisation (IMO) held in London (United Kingdom) from 16 to 20 September 2024. The session was presided over by the subcommittee chair Miss MaryAnne Adams, ably assisted by the Vice-Chair Mr. David Anderson. CCC 10 was a very fruitful and productive meeting with insightful proposals to amend some international conventions such as the SOLAS Convention, the International Convention for Safe Containers (CSC Convention), as well as the Code of Safe Practice for Cargo Stowage and Securing (CSS Code). Adopted amendments will reshape the maritime regulatory landscape worldwide and seek to reduce significantly the frequency and impact of container losses at sea, thereby enhancing maritime safety and environmental protection. Statistics hold that only 221 containers were lost at sea (of which 33 % were recovered), out of the 250 million containers transported in 2023 and the IMO further wants to guarantee container safety through the development of measures to prevent the loss of containers at sea in the biennial agenda of the CCC Sub-Committee for the 2024-2025 biennium. For effective monitoring, SOLAS Regulations V/31 and V/32 require a mandatory reporting of lost containers at sea as from 1 January 2026. Beyond this regulatory approach, shipping lines and cargo handlers are encouraged to use software to supplement the cargo securing manual or loading software for greater safety in their operations. The industry has developed solutions considering the requirements of shipping stakeholders, including the BoxTech database of the BIC (Bureau of International Containers).

CNSC organises a capacity-building workshop.



pon recommendation by the Shippers' Assistance Department, the Cameroon National Shippers' Council (CNSC) organised a training workshop from 26 to 27 November 2024 themed: "Mastering airfreight import and export procedures". The workshop was chaired by CNSC Director for Shippers' Assistance, Mrs. Claire Onana Takouchop. Over a hundred importers, exporters and foreign trade actors took part in the training workshop. Presentations were delivered by experts from the CNSC, the Customs Department, the Ministry of Agriculture and Rural Development. and a Licensed Customs Broker. Discussions focused on 4 main topics: ECTN issuance procedures for airfreight import/export operations; mastering airfreight import/export procedures; sanitary and phytosanitary standards and procedures for airfreight import/ export in Cameroon; as well as the applicable customs requirements.

or the 6th time, Cameroon, through the Douala Maritime Museum, was present at the 39th International Tourism and Travel Show. The show opened its doors on 9 November 2024 at the Parc des expositions in Colmar, France, with some 200 exhibitors from all over the world. This presence in Colmar was to highlight Cameroon as a tourist destination, and to showcase the Douala Maritime Museum, which focuses on Cameroon's maritime heritage. For greater visibility, the Douala Maritime Museum's stand was decorated with photographs providing information on the different activities and digital attractions offered to the public. Visitors were welcomed in batches by the staff, who provide information on the museum's origins, Cameroon's maritime history, artefacts depicting man in his natural environment, and the centuries-old relationship man has had with water. On the sidelines of the show, the non-governmental organisation Tourisme Sans Frontière (TSF), chaired by Mr. Marc Dumoulin, held its board meeting in Colmar on 10 November 2024, and the Douala Maritime Museum was equally present there. The focus of the meeting was to take stock of existing partnerships with TSF and to look at the prospects for a more fruitful collaboration with its various members. This is notably the case of the Douala Maritime Museum which enjoyed technical assistance from TSF during its organisation of the 7th Conference on Responsible and Sustainable Tourism in 2020 in Douala - Cameroon.
